Tuition Assistance Veritas Academy offers need-based financial assistance to families on a first-come, first-served basis as funds are available. Levels of tuition assistance offered will depend on a number of factors including total (gross) family income, number of family members, and the number of children enrolled at Veritas. If you are applying for financial assistance to help with tuition expenses, **you must complete a FACTS financial aid application online (see www.veritassavannah.org/admissions/financial-aid) and submit all required documentation to FACTS BEFORE MARCH 1.** It is expected that families will pursue every other available means of financial assistance (family, other scholarship funds, etc.) prior to applying for aid directly from Veritas.

Enrollment Deposit Families whose children have been accepted to Veritas will receive an enrollment contract that must be signed and returned to the school. This signed enrollment contract must be accompanied by an enrollment deposit totaling one-twelfth (1/12) of the family’s total tuition obligation. Payment of the enrollment deposit will guarantee your child’s placement in the classroom.

Families who are currently making monthly payments may sign their contract and request a deferral on the one-twelfth enrollment deposit until May 1.

Payment Plans The remaining tuition balance after payment of the one-twelfth deposit may be paid using one of the following payment plans:

1-Pay Plan: One (1) lump sum payment due on June 1, 2018. There is no discount for this early lump sum payment.

12-Pay Plan: Twelve (12) equal payments due on or before the first day of each month beginning with June 1, 2018, with the final payment due on or before May 1, 2019. If the one-twelfth enrollment deposit payment is paid prior to May 1, 2018, eleven monthly payments will begin July 1, 2018 and continue through May 1, 2019.

Payments on the 12-Pay Plan must be made electronically through FACTS and will incur a one-time processing fee from FACTS. Once you sign and submit your enrollment contract, you must immediately create an account login and enter your payment information for FACTS processing. RETURNING FAMILIES Timeline:

- January 1** Formal enrollment season begins.
- February 1** **NEW SIBLING APPLICATION DEADLINE:** Applications for NEW SIBLINGS (with accompanying records and documents) must be submitted by this date. Enrollment Assessment Testing for new siblings of returning students will take place in February. The school will notify applicants when they are to be tested.
- February 15** **FACTS FINANCIAL AID APPLICATION DEADLINE:** If you are applying for financial assistance to help with tuition expenses for 2018-2019, you must complete a FACTS financial aid application (**see www.veritassavannah.org/admissions/financial-aid**.) and submit all required documentation to FACTS by February 15 in order to receive priority consideration for assistance.
- NOTE: The FACTS application for 2018-2019 financial aid will require that you provide 2016 tax returns and 2017 W-2 statements. You will NOT need to complete your 2017 tax returns before completing the FACTS financial aid application.*
- Applications for financial assistance WILL BE ACCEPTED AFTER THE ABOVE DATES and will be considered as the school has available funds.**
- February 26** **ENROLLMENT CONTRACTS ISSUED:** Enrollment contracts and acceptance letters will be issued by March 1. Notifications of financial assistance will be included in the contracts.
- March 7** **SIGNED ENROLLMENT CONTRACTS & DEPOSITS DUE:** Enrollment contracts and deposits must be returned to the school. **Returning families who do not submit their contract by this date will not be given priority in filling available spaces or priority in financial aid awards. Veritas will guarantee classroom placement and financial aid awards only if the contract and deposit are received by March 7.**
- One-twelfth (1/12) of the total tuition due must be paid as a deposit with the signed contract. Families who are currently making monthly payments on their 2017-2018 tuition may sign their contract and request a deferral on the one-twelfth deposit until June 1.
- AFTER March 7, 2018** applications for admission and financial aid for returning and new families will be processed and considered as the school has openings and as financial aid funds are available.
